## IPM statement

It is the goal of BCLC to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

## Pest management contracting

- Pest management services are contracted to a licensed pest control business.

- Prior to entering into a contract, the school district has confirmed that the pest control business understands the training requirement and other requirements of the Healthy Schools Act.

## Pest identification, monitoring and inspection

Pest Identification is done by: Contracted pest management company, all staff on-site, Vector Control of Orange County  
*(Example: College/University staff, Pest Control Business, etc.)*

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by Coordinator, Staff, Pest Management Company and results are communicated to the IPM Coordinator.  
*(Example: District staff title, e.g. Maintenance staff)*

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:  
*(Example: Sticky monitoring boards are placed in the kitchen and are checked weekly by custodial staff.)*

Custodian will inspect inside and out 2 times every week after the center closes. Housekeeper will inspect inside and out 2 times per week just before center opens. Staff members will report any and all pest or pest related sightings in their work areas.

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt<sup>1</sup> from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at [www.cdpr.ca.gov/schoolipm](http://www.cdpr.ca.gov/schoolipm). (Education Code Section 16711)

(Education Code Section 17610.5)
